- The Coast Water Works Development Agency (CWWDA) has received a funds from the Government of Kenya through 1 the Ministry of Water and Sanitation & Irrigation toward the cost of the 'Construction of the Makamini Dam Phase I', and intends to use part of the funds thereof for payments under the following Contract: Consultancy Services for Review Detailed Design Documentation and Construction Supervision of Makamini Dam Works under **Design Build Model**

 - The consulting services of this assignment ("the Services") include: a) Review of detailed design documentation done by the Contractor (feasibility studies, preliminary designs, detailed designs, cost estimates, ESIA, RAP etc.)

- The Coast Water Works Development Agency, a state corporation under the Ministry of Water and Sanitation & Irrigation (MWS&I), now invites eligible consulting firms ("Consultants") to indicate their interest in providing the 3 Services.
- 4 Interested Consultancy firms must provide information evidencing that they are qualified and experienced to perform those services, such as:
 - Presentation of the Consultancy firm: general presentation, scope of activities, financial data (sales figures, al financial statements etc.) for the past three (3) years, description of human resource capacity etc. Ь٦
 - Experience on similar projects during the last ten (10) years. Similar projects include preliminary designs, detailed designs, feasibility studies, safeguards documents, preparation of tender documents and works
 - supervision for the following infrastructure (FIDIC Design Build Yellow Book): o Earthfill Dam with earthworks volume of at least 250,000m³ or reservoir capacity of at least 4 million cubic meters
 - Raw water pipeline and Rising Mains (at least one (1) kilometer and diameter of 300 mm or larger), 0
 - Water Treatment Plant of a capacity of at least 3,000 m³/d, Water storage tank, at least 1000 m³. 0

For evaluation purposes, past projects combining preliminary design, safeguards documents, tender document preparation and works supervision will be an added advantage
